The Local Governing Body meet termly (3 times per year) and it is important that you are able to attend these meetings so that you are up to date and able to contribute fully to discussions. If meetings are held in school time, where possible arrangements will be made to cover your work so that you may attend.

Governor visits are an important aspect of effective governance. You may be assigned a specific 'link role' but this will depend on time commitments.

To carry out your role we provide appropriate induction training soon after you take up office. You can also access a wide range of training opportunities to support your development. All governance appointments are subject to an enhanced DBS check, a Section 128 check and must attend Safeguarding training as soon as possible.
